

**THE CORPORATION OF THE TOWN OF COCHRANE**

**BY-LAW NUMBER 608-2009**

BEING A BY-LAW TO APPOINT A MUNICIPAL LAW ENFORCEMENT OFFICER AND AN ALTERNATE TO ENFORCE ALL WATER USE BY-LAWS FOR THE TOWN OF COCHRANE

**WHEREAS** Council may, pursuant to Section 227 of the Municipal Act, S.O. 2001, Chapter c. 25, appoint such officers or employees as may be necessary for the purposes of the corporation;

**AND WHEREAS** under Section 15(1), (2), of the Police Services Act, R.S.O., 1990, Chapter P.15, as amended, a Municipal Council may appoint persons to enforce the by-laws of the municipality and that such Municipal Law Enforcement Officers are peace officers for the purpose of enforcing municipal by-laws;

**AND WHEREAS** the Corporation of the Town of Cochrane deems it expedient to appoint a Municipal Law Enforcement Officer and an Alternate to enforce all water use by-laws for the Town of Cochrane;

**NOW THEREFORE** the Municipal Council of the Corporation of the Town of Cochrane enacts as follows:

1. **THAT** Shane Skinner is hereby appointed as Municipal Law Enforcement Officer (MLEO) for the Town of Cochrane;
2. **THAT** Kenneth McWhirter is hereby appointed as MLEO Alternate for the Town of Cochrane;
3. **THAT** this By-Law shall come into force and take effect on the date of its final passing.
