

ADMINISTRATIVE REPORT

Surplus land 16th Avenue

BACKGROUND:

The Town of Cochrane holds (3) three parcels of land at the South end of Sixteenth Avenue. The lots are abutting residential occupancies to the West and industrial to the East and South. Council finds it desirable to sell the parcel of land at a fair market price.

RECOMMENDATIONS/RESOLUTION:

That Council surplus lot 704, lot 716, 717 and lot 718 from Plan M114NB.

ANALYSIS & DISCUSSION:

The lots being surplus are zoned residential as per zoning by-law 968-2013. Council can re-zone the lots to commercial or industrial which would be a better fit for the location.

All of the lots have water and sanitary available and road access. The Town does receive request for such lots during the year, in recent years the Town has made all of its lots available for sale to the public at a fair market price.






